TERMS

By signing this credit application/agreement, the individual executing this Application on behalf of the Buyer, individually and personally, represents and warrants to THE DISTRIBUTION POINT that 1) he/she is authorized to execute this Application on behalf of Buyer; 2) the information set forth in this Application is accurate and complete.

Buyer agrees that the prevailing party in any proceeding to enforce this contract or to resolve a dispute with THE DISTRIBUTION POINT will be entitled to recover its costs, including attorneys' fees, collection agency fees, from the other party; and any legal action brought by Buyer will be in the jurisdiction of St. Clair County, Alabama. Buyer hereby submits to the jurisdiction of said courts. The laws of the State of Alabama will apply.

Buyer agrees that THE DISTRIBUTION POINT reserves the right to submit all disputes to final and binding arbitration, in the state of Alabama, in accordance with the commercial rules of the American Arbitration Association. Applicant agrees to be bound by the arbitrator's decision in such cases.

THE DISTRIBUTION POINT reserves its right, at its sole discretion and without notice, to cancel all available credit and refuse to make future advances.

Buyer agrees to examine immediately upon receipt, all materials received and each of THE DISTRIBUTION POINT's invoices, and to advise THE DISTRIBUTION POINT of any dispute or damage within 10 days of receipt. Failure to notify THE DISTRIBUTION POINT of any dispute with respect to defective goods or billing shall constitute a waiver of all such disputes. Claims and returns must be made within seven working days and returns must be accompanied by RGA number obtained from THE DISTRIBUTION POINT and is subject to restocking charges.

The parties hereto agree that all actions or proceedings arising in connection with this Agreement shall be tried and litigated exclusively in the State and Federal courts located in the County of Jefferson, State of Alabama without a jury, said right to a jury being specifically waived hereby. The aforementioned choice of venue is intended by the parties to be mandatory and not permissive in nature, thereby precluding the possibility of litigation between the parties with respect to or arising out of this Agreement in any jurisdiction other than that specified in this paragraph. Each party hereby waives any right it may have to assert the doctrine of forum non conveniens or similar doctrine or to object to venue with respect to any proceeding brought in accordance with this paragraph, and stipulates that the State and Federal courts located in the County of Jefferson, State of Alabama shall have in personam jurisdiction and venue over each of them for the purpose of litigating any dispute, controversy, or proceeding arising out of or related to this Agreement. Each party hereby authorizes and accepts service of process sufficient for personal jurisdiction in any action against it as contemplated by this paragraph by registered or certified mail, return receipt requested, postage prepaid, to its address for the giving of notices as set forth in this Agreement. Any final judgment rendered against a party in any action or proceeding shall be conclusive as to the subject of such final judgment and may be enforced in other jurisdictions in any manner provided by law.

Payment terms may vary by order and are indicated on each invoice. Buyer agrees to pay interest on any unpaid purchases, beginning 30 days after the payment due date, at the rate of 1.5% per month, (18% per annum), or the maximum judicial rate, whichever is less. Buyer also agrees to pay \$35 for each check issued by Buyer to THE DISTRIBUTION POINT which is returned to THE DISTRIBUTION POINT unpaid or marked NSF.

In signing this Application, Buyer agrees to all of the above and hereby grants permission for credit information to be verified by companies and financial institution(s) that the Buyer has specified on this document and others that THE DISTRIBUTION POINT becomes aware of during the credit review process and from time to time. Buyer certifies that this credit application request is for the extension of credit for business purposes only and is not intended for the extension of credit for personal, family or household purposes.

The undersigned also understands that THE DISTRIBUTION POINT will retain this Application whether or not it is approved, and that THE DISTRIBUTION POINT will consider this Application as a continuing statement of the applicant's financial position and situation unless the Buyer notifies THE DISTRIBUTION POINT in writing, and by certified mail of any change in ownership, the business name, the business structure and/or the financial status and solvency of the Buyer's company under which credit is established.

In order for THE DISTRIBUTION POINT to sell and to continue to sell to Buyer, Buyer hereby represents and warrants that it is solvent and that it pays its obligations as they become due. The preceding representation and agreement will be deemed to be repeated in each purchase by Buyer. Buyer also agrees to notify THE DISTRIBUTION POINT in writing, and by certified mail of any change in ownership, the business name, or the business structure under which credit is established.

Faxed documents will be deemed as original. No oral agreements will be accepted. The terms on this credit application/agreement overrides all others, including Buyer's purchase orders.

This application/agreement shall be interpreted under the laws of the State of Alabama.
